- d) To purchase and acquire any immovable property of any kind for this object of the Trust or as a source of income for the Trust; and to sell, mortgage, or dispose of any immovable property/properties belonging to the Trust;
- e) To incur all expenditure necessary as in their own opinion useful for carrying out the objects and administration of thetrust;
- f) To engage the services of Advocates, Chartered Accountants and other experts for the purpose of the Trust and to pay the remuneration as may be found necessary.
- g) To open one or more bank accounts of the trust with any bank or banks as the Trustees may deem fit and deposit monies of the Trust in the Bankaccounts.
- To borrow for and on behalf of the Trust with or without security from banks, Governments, Universities or any other government Body/bodies both central andstate;
- i) to employ or terminate or otherwise dismiss staff of all kinds necessary and useful for carrying out the objects of the trust.
- j) To incur such other items of expenditure as is necessary and incidental for carrying out the objects of the Trust;
- k) To institute, conduct, defend, compound, withdraw, compromise, adjust, refer toarbitrationortodosuchthingsasareincidentalandnecessary, concerning the affairs of the Trust and to sign and verify vakalats, pleadings, affidavits

- To delegate all or any of the powers vested in the Trustees to anybody' to frame rules, bylaws and other codes for the conduct of the affairs of the Trust and its transactions and establishing anyCommittee;
- m) To accept contributions in cash or in kind either by way of addition to the trust funds generally or for any one or more of the specified objects of the Trust.

n) To establish as many adhoc committees for anypurpose.

O) The number of Trustee shall not be less than 3(Three) and shall not exceed 10 10(Ten). Any new Trustee may be appointed through a resolution passed at the duly convened meeting by a majority of the 51% of the Trustee on Board. Each of the Trustee is empowered to nominate his/her successor who is acceptable for the other Trustees who shall hold office for their term. In event of death of a Trustee without nominating any person as Trustee the remaining Trustees shall be empowered to appoint any other person as a Trustee to fill-up the vacancy caused by the death of the Trustee.

12. Meetings of the Trustees:

a) That the Board of Trustees shall meet at least 4 times a year to discuss the matters concerning the working of the Trust.

b) Two members of the Board of Trustee shall be the Quorum for such a meeting. However, there shall no Quorum for adjourned meeting.

c) For all meeting of the Trustees shall give seven days' notice and in case of emergency a meeting may be called without giving seven days' notice.

d) The Managing Trustee shall preside over all the meetings of the trustees and in his absence the Joint Managing Trustee shall preside such meeting and in the absence of both, the trustees attended such meeting may elect any one of them to preside over themeeting;

e) The meetings of the Trustees may be convened by the Managing Trustee or

f) The quorum of the meeting of the Trustees shall be three personally present.

g) In the event of equality of votes, the person presiding such meeting shall exercise casting vote (additional vote).

13. RESOLUTIONS:

- d) The accounts of the Trust shall be audited every year by a Chartered Accountant who may be appointed for the purpose by the board of Trustees and the audited statement of accounts together with Auditors' report shall be laid before the Board of Trustees forapproval.

17. BANKACCOUNT:

The Managing Trustee withany one Either or Survivor of Joint Trustee shall operate bank account(s)jointly.

18. POWER TO ALTER RULES ANDREGULATIONS:

The Board of Trustees shall have full power and authority to make, alter and rescind rules and regulations for the management and administration of the Trust. Any amendment to the Trust Deed will be carried out only with the approval of the Commissioner of IncomeTax.

19. APPLICATION OF INCOME AND TRUSTFUND:

The Board of Trustees shall be empowered to invest the funds of the Trust in movable or immovable properties, in such manner as they deem fit for the purpose of the objects of the trust provided that such investments shall be in accordance with the provision of Section 13(I) read with Section 11(5) of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable trusts.

On dissolution of the Trust, the net assets of the Trust shall be transferred to an association of persons or trust or society having similar objects of this Trust.

25. PROCEEDING OF THETRUST:

Any defect in the constitution of the Trust shall not invalidate its proceedings

26. RESIDUARY:

For matters not provided for in these presents, the provisions of the Indian Trust Act and the Income Tax Act,1961 and rules made there under will apply accordingly.
